In light of your repeated offers "to meet with government officials, [and] to testify before the U.S. Congress," the Oversight Subcommittee of the Committee on Science, Space, and Technology of the U.S. House of Representatives requests your presence at a hearing on Wednesday, September 27, 2017, at 10:00 a.m. in room 2318 of the Rayburn House Office Building. The purpose of this hearing is to conduct oversight of the cybersecurity posture of the federal government, and examine the extent to which the federal government utilizes your company's products. The Subcommittee will also review the implementation of Executive Order 13800 and the NIST Cybersecurity Framework by federal departments and agencies.

To allow sufficient time for questions at the hearing, please highlight the most significant points of your testimony in an oral presentation of no more than five minutes. You are requested to submit a written statement, which may be of any reasonable length and may contain supplemental materials; however, please be aware that the Committee cannot guarantee that supplemental material will be included in the printed hearing record. Please include a one-page summary of the major points you wish to make. Oral statements and answers to Member questions will be printed as part of the verbatim record of the hearing; only technical, grammatical, and typographical errors will be corrected.

Witnesses testifying before the Committee on Science, Space, and Technology must observe procedures governing witness testimony. These procedures are described in the following enclosures and provide important details concerning the preparation and presentation
