A BILL

To amend the Energy Independence and Security Act of 2007 and the Energy Policy Act of 2005 to direct Federal research on grid modernization and security, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Grid Modernization Research and Development Act of
6 2019”.

1 (b) TABLE OF CONTENTS.—The table of contents for

3 **SEC. 2. SMART GRID REGIONAL DEMONSTRATION INITIA-**
4 **TIVE.**

5 Section 1304 of the Energy Independence and Secu-
6 rity Act of 2007 (42 U.S.C. 17384) is amended—

7 (1) in subsection (a), by inserting “research,
8 development, and demonstration” before “program”;

9 (2) in subsection (b)—

10 (A) by amending paragraph (1) to read as
11 follows:

12 “(1) The Secretary shall establish a smart grid
13 regional demonstration initiative (referred to in this
14 subsection as the ‘Initiative’) composed of dem-
15 onstration projects focused on cost-effective, ad-
16 vanced technologies for use in power grid sensing,
17 communications, analysis, power flow control, visual-
18 ization, distribution automation, industrial control
19 systems, dynamic line rating systems, grid redesign,

1 and the integration of distributed energy re-
2 sources.”; and

3 (B) in paragraph (2)—

4 (i) in subparagraph (D), by striking
5 “and”;

6 (ii) in subparagraph (E), by striking
7 the period and inserting “; and”; and

8 (iii) by inserting at the end the fol-
9 lowing:

10 “(F) to encourage the commercial applica-
11 tion of advanced distribution automation tech-
12 nologies that improve system resilience.”.

13 **SEC. 3. SMART GRID MODELING, VISUALIZATION, ARCHI-**
14 **TECTURE, AND CONTROLS.**

15 Title XIII of the Energy Independence and Security
16 Act of 2007 (42 U.S.C. 17381 et seq.) is amended by in-
17 serting after section 1304 the following:

18 **“SEC. 1304a. SMART GRID MODELING, VISUALIZATION, AR-**
19 **CHITECTURE, AND CONTROLS.**

20 “(a) IN GENERAL.—Not later than 180 days after
21 the enactment of the Grid Modernization Research and
22 Development Act of 2019, the Secretary shall establish a
23 program of research, development, demonstration, and
24 commercial application on electric grid modeling, sensing,

1 visualization, architecture development, and advanced op-
2 eration and controls.

3 “(b) MODELING RESEARCH AND DEVELOPMENT.—

4 The Secretary shall support development of models of
5 emerging technologies and systems to facilitate the secure
6 and reliable design, planning, and operation of the electric
7 grid for use by industry stakeholders. In particular, the
8 Secretary shall support development of—

9 “(1) models to analyze and predict the effects
10 of adverse physical and cyber events on the electric
11 grid;

12 “(2) coupled models of electrical, physical, and
13 cyber systems;

14 “(3) models of existing and emerging tech-
15 nologies being deployed on the electric grid due to
16 projected changes in the electric generation mix and
17 loads, for a variety of regional characteristics; and

18 “(4) integrated models of the communications,
19 transmission, distribution, and other interdependent
20 systems for existing, new, and emerging tech-
21 nologies.

22 “(c) SITUATIONAL AWARENESS RESEARCH AND DE-
23 VELOPMENT.—

24 “(1) IN GENERAL.—The Secretary shall sup-
25 port development of computational tools and tech-

1 nologies to improve sensing, monitoring, and visual-
2 ization of the electric grid for real-time situational
3 awareness and decision support tools that enable im-
4 proved operation of the power system, including util-
5 ity, non-utility, and customer grid-connected assets,
6 for use by industry partners.

7 “(2) DATA USE.—In developing visualization
8 capabilities under this section, the Secretary shall
9 develop tools for industry stakeholders to use to ana-
10 lyze data collected from advanced measurement and
11 monitoring technologies, including data from phasor
12 measurement units and advanced metering units.

13 “(3) SEVERE EVENTS.—The Secretary shall
14 prioritize enhancing cyber and physical situational
15 awareness of the electric grid during adverse man-
16 made and naturally-occurring events.

17 “(d) ARCHITECTURE.—The Secretary shall conduct
18 research in collaboration with industry stakeholders to de-
19 velop model grid architectures to assist with wide-area
20 transmission and distribution planning that incorporate
21 expected changes to the modern electric grid. In sup-
22 porting the development of model grid architectures, the
23 Secretary shall—

24 “(1) analyze a variety of grid architecture sce-
25 narios that range from minor upgrades to existing

1 transmission grid infrastructure to scenarios that in-
2 volve the replacement of significant portions of exist-
3 ing transmission grid infrastructure;

4 “(2) analyze the effects of the increasing pro-
5 liferation of renewable and other zero emissions en-
6 ergy generation sources, increasing use of distrib-
7 uted resources owned by non-utility entities, and the
8 use of digital and automated controls not managed
9 by grid operators;

10 “(3) include a variety of new and emerging dis-
11 tribution grid technologies, including distributed en-
12 ergy resources, electric vehicle charging stations, dis-
13 tribution automation technologies, energy storage,
14 and renewable energy sources;

15 “(4) analyze the effects of local load balancing
16 and other forms of decentralized control;

17 “(5) analyze the effects of changes to grid ar-
18 chitectures resulting from modernizing electric grid
19 systems, including communications, controls, mar-
20 kets, consumer choice, emergency response, elec-
21 trification, and cybersecurity concerns; and

22 “(6) develop integrated grid architectures that
23 incorporate system resilience for cyber, physical, and
24 communications systems.

1 “(e) OPERATION AND CONTROLS RESEARCH AND
2 DEVELOPMENT.—The Secretary shall conduct research to
3 develop improvements to the operation and controls of the
4 electric grid, in coordination with industry partners. Such
5 activities shall include—

6 “(1) a training facility or facilities to allow grid
7 operators to gain operational experience with ad-
8 vanced grid control concepts and technologies;

9 “(2) development of cost-effective advanced op-
10 eration and control concepts and technologies, such
11 as adaptive islanding, dynamic line rating systems,
12 power flow controllers, network topology optimiza-
13 tion, smart circuit breakers, intelligent load shed-
14 ding, and fault-tolerant control system architectures;

15 “(3) development of real-time control concepts
16 using artificial intelligence and machine learning for
17 improved electric grid resilience; and

18 “(4) utilization of advanced data analytics in-
19 cluding load forecasting, power flow modeling, equip-
20 ment failure prediction, resource optimization, risk
21 analysis, and decision analysis.

22 “(f) COMPUTING RESOURCES AND DATA COORDINA-
23 TION RESEARCH AND DEVELOPMENT.—In carrying out
24 this section, the Secretary shall—

1 “(1) leverage existing computing resources at
2 the National Laboratories;

3 “(2) develop voluntary standards for data
4 taxonomies and communication protocols in coordi-
5 nation with public and private sector stakeholders;
6 and

7 “(3) comply with section 8 of the Grid Mod-
8 ernization Research and Development Act of 2019.

9 “(g) INFORMATION SHARING.—None of the activities
10 authorized in this section shall require private entities to
11 share information or data with the Secretary.”.

12 **SEC. 4. ENHANCING GRID RESILIENCE AND EMERGENCY**
13 **RESPONSE.**

14 Title XIII of the Energy Independence and Security
15 Act of 2007 (42 U.S.C. 17381 et. seq.) is amended by
16 adding at the end the following:

17 **“SEC. 1310. GRID RESILIENCE AND EMERGENCY RESPONSE.**

18 “(a) IN GENERAL.—Not later than 180 days after
19 the enactment of the Grid Modernization Research and
20 Development Act of 2019, the Secretary shall establish a
21 research, development, and demonstration program to en-
22 hance resilience and strengthen emergency response and
23 management pertaining to the electric grid.

24 “(b) GRANTS.—The Secretary shall award grants to
25 eligible entities under subsection (c) on a competitive basis

1 to conduct research and development with the purpose of
2 improving the resilience and reliability of electric grid by—

3 “(1) developing methods to improve community
4 and governmental preparation for and emergency re-
5 sponse to large-area, long-duration electricity inter-
6 ruptions, including through the use of energy effi-
7 ciency, storage, and distributed generation tech-
8 nologies;

9 “(2) developing tools to help utilities and com-
10 munities ensure the continuous delivery of electricity
11 to critical facilities;

12 “(3) developing tools to improve coordination
13 between utilities and relevant Federal agencies to
14 enable communication, information-sharing, and sit-
15 uational awareness in the event of a physical or
16 cyber attack on the electric grid;

17 “(4) developing technologies and capabilities to
18 withstand and address the current and projected im-
19 pact of the changing climate on electric grid infra-
20 structure, including extreme weather events and
21 other natural disasters;

22 “(5) developing technologies capable of early
23 detection of deteriorating electrical equipment on the
24 transmission and distribution grid, including detec-

1 tion of spark ignition from wildfires and risks of
2 vegetation contact; and

3 “(6) assessing upgrades and additions needed
4 to electric grid infrastructure due to projected
5 changes in the electricity generation mix and elec-
6 tricity demand.

7 “(c) ELIGIBLE ENTITIES.—The entities eligible to re-
8 ceive grants under this section include—

9 “(1) an institution of higher education;

10 “(2) a nonprofit organization;

11 “(3) a National Laboratory;

12 “(4) a unit of State, local, or tribal government;

13 “(5) an electric utility or electric cooperative;

14 “(6) a retail service provider of electricity;

15 “(7) a private commercial entity;

16 “(8) a partnership or consortium of 2 or more
17 entities described in subparagraphs (1) through (7).

18 “(d) RELEVANT ACTIVITIES.—Grants awarded under
19 subsection (b) shall include funding for research and de-
20 velopment activities related to the purpose described in
21 subsection (b), such as—

22 “(1) development of technologies to use distrib-
23 uted energy resources, such as solar photovoltaics,
24 energy storage systems, electric vehicles, and

1 microgrids to improve grid and critical end-user re-
2 silience;

3 “(2) analysis of past large-area, long-duration
4 electricity interruptions to identify common elements
5 and best practices for electricity restoration, mitiga-
6 tion, and prevention of future disruptions;

7 “(3) development of advanced monitoring, ana-
8 lytics, operation, and controls of electricity grid sys-
9 tems to improve electric grid resilience;

10 “(4) analysis of technologies, methods, and con-
11 cepts that can improve community resilience and
12 survivability of frequent or long-duration power out-
13 ages;

14 “(5) development of methodologies to maintain
15 cybersecurity during restoration of electric grid in-
16 frastructure and operation;

17 “(6) development of advanced power flow con-
18 trol systems and components to improve electric grid
19 resilience; and

20 “(7) any other relevant activities determined by
21 the Secretary.

22 “(e) TECHNICAL ASSISTANCE.—

23 “(1) IN GENERAL.—The Secretary shall provide
24 technical assistance to eligible entities for the com-
25 mercial application of technologies to improve the re-

1 silience of the electric grid and commercial applica-
2 tion of technologies to help entities develop plans for
3 preventing and recovering from various power out-
4 age scenarios at the local, regional, and State level.

5 “(2) TECHNICAL ASSISTANCE PROGRAM.—The
6 technical assistance program established in para-
7 graph (1) shall include assistance to eligible entities
8 for—

9 “(A) the commercial application of tech-
10 nologies developed from the grant program es-
11 tablished in subsection (b), including municipal
12 and cooperative utilities;

13 “(B) the development of methods to
14 strengthen or otherwise mitigate adverse im-
15 pacts on electric grid infrastructure against
16 natural hazards;

17 “(C) the use of Department data and mod-
18 eling tools for various purposes; and

19 “(D) a resource assessment and analysis of
20 future demand and distribution requirements,
21 including development of advanced grid archi-
22 tectures and risk analysis.

23 “(3) ELIGIBLE ENTITIES.—The entities eligible
24 to receive technical assistance for commercial appli-
25 cation of technologies under this section include—

1 “(A) representatives of all sectors of the
2 electric power industry, including electric utili-
3 ties, trade organizations, and transmission and
4 distribution system organizations, owners, and
5 operators;

6 “(B) State and local governments and reg-
7 ulatory authorities, including public utility com-
8 missions;

9 “(C) tribal and Alaska Native govern-
10 mental entities;

11 “(D) partnerships among entities under
12 subparagraphs (A) through (C);

13 “(E) regional partnerships; and

14 “(F) any other entities the Secretary
15 deems appropriate.

16 “(4) AUTHORITY.—Nothing in this section shall
17 authorize the Secretary to require any entity to
18 adopt any model, tool, technology, plan, analysis, or
19 assessment.

20 “(f) COORDINATION.—In carrying out this section,
21 the Secretary shall comply with section 8 of the Grid Mod-
22 ernization Research and Development Act of 2019.”.

1 **SEC. 5. HYBRID ENERGY SYSTEMS.**

2 Title XIII of the Energy Independence and Security
3 Act of 2007 (42 U.S.C. 17381 et. seq.), as amended, is
4 amended by adding at the end the following:

5 **“SEC. 1311. HYBRID ENERGY SYSTEMS.**

6 “(a) IN GENERAL.—Not later than 180 days after
7 the enactment of the Grid Modernization Research and
8 Development Act of 2019, the Secretary shall establish a
9 research, development, and demonstration program to de-
10 velop cost-effective hybrid energy systems, including—

11 “(1) development of computer modeling to de-
12 sign different configurations of hybrid energy sys-
13 tems and to optimize system operation;

14 “(2) research on system integration needed to
15 plan, design, build, and operate hybrid energy sys-
16 tems, including interconnection requirements with
17 the electric grid;

18 “(3) development of hybrid energy systems for
19 various applications, including—

20 “(A) thermal energy generation and stor-
21 age for buildings and manufacturing;

22 “(B) electricity storage coupled with en-
23 ergy generation;

24 “(C) desalination;

25 “(D) production of liquid and gaseous
26 fuels; and

1 “(E) production of chemicals such as am-
2 monia and ethylene;

3 “(4) development of testing facilities for hybrid
4 energy systems; and

5 “(5) research on incorporation of various tech-
6 nologies for hybrid energy systems, including nuclear
7 energy, renewable energy, storage, and carbon cap-
8 ture, utilization, and sequestration technologies.

9 “(b) STRATEGIC PLAN.—

10 “(1) IN GENERAL.—Not later than 1 year after
11 the date of the enactment of the Grid Modernization
12 Research and Development Act of 2019, the Sec-
13 retary shall submit to the Committee on Science,
14 Space, and Technology of the House of Representa-
15 tives and the Committee on Energy and Natural Re-
16 sources of the Senate a strategic plan that identifies
17 opportunities, challenges, and standards needed for
18 the development and commercial application of hy-
19 brid energy systems. The strategic plan shall in-
20 clude—

21 “(A) analysis of the potential benefits of
22 development of hybrid electric systems on the
23 electric grid;

1 “(B) analysis of the potential contributions
2 of hybrid energy systems to different grid archi-
3 tecture scenarios;

4 “(C) research and development goals for
5 various hybrid energy systems, including those
6 identified in subsection (b);

7 “(D) assessment of policy and market bar-
8 riers to the adoption of hybrid energy systems;

9 “(E) analysis of the technical and eco-
10 nomic feasibility of adoption of different hybrid
11 energy systems; and

12 “(F) a 10-year roadmap to guide the pro-
13 gram established under subsection (a).

14 “(2) UPDATES.—Not less than once every 3
15 years for the duration of this research program, the
16 Secretary shall submit an updated version of the
17 strategic plan to the Committee on Science, Space,
18 and Technology of the House of Representatives and
19 the Committee on Energy and Natural Resources of
20 the Senate.

21 “(c) PROGRAM IMPLEMENTATION.—In carrying out
22 the research, development, demonstration, and commercial
23 application aims of section, the Secretary shall—

24 “(1) implement the recommendations set forth
25 in the strategic plan in subsection (b);

1 “(2) coordinate across all relevant program of-
2 fices at the Department, including—

3 “(A) the Office of Energy Efficiency and
4 Renewable Energy;

5 “(B) the Office of Nuclear Energy; and

6 “(C) the Office of Fossil Energy;

7 “(3) leverage existing programs and resources
8 of the Department;

9 “(4) prioritize activities that accelerate the de-
10 velopment of integrated electricity generation, stor-
11 age, and distribution systems with net zero green-
12 house gas emissions; and

13 “(5) comply with section 8 of the Grid Mod-
14 ernization Research and Development Act of 2019.

15 “(d) HYBRID ENERGY SYSTEM DEFINED.—The term
16 ‘hybrid energy system’ means a system composed of 2 or
17 more co-located or jointly operated sub-systems of energy
18 generation, energy storage, or other energy technologies.”.

19 **SEC. 6. GRID INTEGRATION RESEARCH AND DEVELOP-**
20 **MENT.**

21 (a) INTEGRATING DISTRIBUTED ENERGY RE-
22 SOURCES ONTO THE ELECTRIC GRID.—Section 925(a) of
23 the Energy Policy Act of 2005 (42 U.S.C. 16215) is
24 amended by—

1 (1) redesignating paragraphs (10) and (11) as
2 paragraphs (12) and (13), respectively; and

3 (2) inserting after paragraph (9) the following:

4 “(10) the development of cost-effective tech-
5 nologies that enable two-way information and power
6 flow between distributed energy resources and the
7 electric grid;

8 “(11) the development of technologies and con-
9 cepts that enable interoperability between distributed
10 energy resources and other behind-the-meter devices
11 and the electric grid;”.

12 (b) INTEGRATING RENEWABLE ENERGY ONTO THE
13 ELECTRIC GRID.—Subtitle C of title IX of the Energy
14 Policy Act of 2005 (42 U.S.C. 16231 et seq.) is amended
15 by adding at the end the following:

16 **“SEC. 936. RESEARCH AND DEVELOPMENT INTO INTE-**
17 **GRATING RENEWABLE ENERGY ONTO THE**
18 **ELECTRIC GRID.**

19 “(a) IN GENERAL.—Not later than 180 days after
20 the enactment of the Grid Modernization Research and
21 Development Act of 2019, the Secretary shall establish a
22 research, development, and demonstration program on
23 technologies that enable integration of renewable energy
24 generation sources onto the electric grid across multiple

1 program offices of the Department. The program shall in-
2 clude—

3 “(1) forecasting for predicting generation from
4 variable renewable energy sources;

5 “(2) development of cost-effective low-loss, long-
6 distance transmission lines; and

7 “(3) development of cost-effective advanced
8 technologies for variable renewable generation
9 sources to provide grid services.

10 “(b) COORDINATION.—In carrying out this program,
11 the Secretary shall—

12 “(1) coordinate across all relevant program of-
13 fices at the Department to achieve the goals estab-
14 lished in this section, including the Office of Elec-
15 tricity; and

16 “(2) comply with section 8 of the Grid Mod-
17 ernization Research and Development Act of 2019.

18 “(c) ADOPTION OF TECHNOLOGIES.—In carrying out
19 this section, the Secretary shall consider barriers to adop-
20 tion and commercial application of technologies that en-
21 able integration of renewable energy sources onto the elec-
22 tric grid, including cost and other economic barriers, and
23 shall coordinate with relevant entities to reduce these bar-
24 riers.”.

1 (c) INTEGRATING ELECTRIC VEHICLES ONTO THE
2 ELECTRIC GRID.—Subtitle B of title I of the Energy Inde-
3 pendence and Security Act of 2007 (42 U.S.C. 17011 et
4 seq.) is amended by adding at the end the following:

5 **“SEC. 137. RESEARCH AND DEVELOPMENT INTO INTE-**
6 **GRATING ELECTRIC VEHICLES ONTO THE**
7 **ELECTRIC GRID.**

8 “(a) IN GENERAL.—The Secretary shall establish a
9 research, development, and demonstration program to ad-
10 vance the integration of electric vehicles, including plug-
11 in hybrid electric vehicles, onto the electric grid.

12 “(b) VEHICLES-TO-GRID INTEGRATION ASSESSMENT
13 REPORT.—Not later than 1 year after the enactment of
14 the Grid Modernization Research and Development Act of
15 2019, the Secretary shall submit to the Committee on
16 Science, Space, and Technology of the House of Rep-
17 resentatives and the Committee on Energy and Natural
18 Resources of the Senate a report on the results of a study
19 that examines the research, development, and demonstra-
20 tion opportunities, challenges, and standards needed for
21 integrating electric vehicles onto the electric grid.

22 “(1) REPORT REQUIREMENTS.—The report
23 shall include—

1 “(A) an evaluation of the use of electric ve-
2 hicles to maintain the reliability of the electric
3 grid, including—

4 “(i) the use of electric vehicles for de-
5 mand response, load shaping, emergency
6 power, and frequency regulation; and

7 “(ii) the potential for the reuse of
8 spent electric vehicle batteries for sta-
9 tionary grid storage;

10 “(B) the impact of grid integration on
11 electric vehicles, including—

12 “(i) the impact of bi-directional elec-
13 tricity flow on battery degradation; and

14 “(ii) the implications of the use of
15 electric vehicles for grid services on origi-
16 nal equipment manufacturer warranties;

17 “(C) the impacts to the electric grid of in-
18 creased penetration of electric vehicles, includ-
19 ing—

20 “(i) the distribution grid infrastruc-
21 ture needed to support an increase in
22 charging capacity;

23 “(ii) strategies for integrating electric
24 vehicles onto the distribution grid while
25 limiting infrastructure upgrades;

1 “(iii) the changes in electricity de-
2 mand over a 24-hour cycle due to electric
3 vehicle charging behavior;

4 “(iv) the load increases expected from
5 electrifying the transportation sector;

6 “(v) the potential for customer incen-
7 tives and other managed charging stations
8 strategies to shift charging off-peak;

9 “(vi) the technology needed to achieve
10 bi-directional power flow on the distribu-
11 tion grid; and

12 “(vii) the implementation of smart
13 charging techniques;

14 “(D) research on the standards needed to
15 integrate electric vehicles with the grid, includ-
16 ing communications systems, protocols, and
17 charging stations, in collaboration with the Na-
18 tional Institute for Standards and Technology;

19 “(E) the cybersecurity challenges and
20 needs associated with electrifying the transpor-
21 tation sector; and

22 “(F) an assessment of the feasibility of
23 adopting technologies developed under the pro-
24 gram established under subsection (a) at De-
25 partment facilities.

1 “(2) RECOMMENDATIONS.—As part of the Ve-
2 hicles-to-Grid Integration Assessment Report, the
3 Secretary shall develop a 10-year roadmap to guide
4 the research, development, and demonstration pro-
5 gram to integrate electric vehicles onto the electric
6 grid.

7 “(3) CONSULTATION.—In developing this re-
8 port, the Secretary shall consult with relevant stake-
9 holders, including—

10 “(A) electric vehicle manufacturers;

11 “(B) electric utilities;

12 “(C) public utility commissions;

13 “(D) vehicle battery manufacturers;

14 “(E) electric vehicle supply equipment
15 manufacturers;

16 “(F) charging infrastructure manufactur-
17 ers;

18 “(G) the National Laboratories; and

19 “(H) other Federal agencies, as the Sec-
20 retary determines appropriate.

21 “(4) UPDATES.—The Secretary shall update
22 the report required under this section every 3 years
23 for the duration of the program under section (a)
24 and shall submit the updated report to the Com-
25 mittee on Science, Space, and Technology of the

1 House of Representatives and the Committee on En-
2 ergy and Natural Resources of the Senate.

3 “(c) PROGRAM IMPLEMENTATION.—In carrying out
4 the research, development, demonstration, and commercial
5 application aims of section, the Secretary shall—

6 “(1) implement the recommendations set forth
7 in the report in subsection (b);

8 “(2) coordinate across all relevant program of-
9 fices at the Department to achieve the goals estab-
10 lished in this section, including the Office of Elec-
11 tricity; and

12 “(3) comply with section 8 of the Grid Mod-
13 ernization Research and Development Act of 2019.

14 “(d) TESTING CAPABILITIES.—The Secretary shall
15 coordinate with the National Laboratories to develop test-
16 ing capabilities for the evaluation, rapid prototyping, and
17 optimization of technologies enabling integration of elec-
18 tric vehicles onto the electric grid.”.

19 (d) RESEARCH AND DEVELOPMENT ON INTEGRATING
20 BUILDINGS ONTO THE ELECTRIC GRID.—Subtitle B of
21 title IV of the Energy Independence and Security Act of
22 2007 (42 U.S.C. 17081 et seq.) is amended by adding at
23 the end the following:

1 **“SEC. 426. ADVANCED INTEGRATION OF BUILDINGS ONTO**
2 **THE ELECTRIC GRID.**

3 “(a) IN GENERAL.—The Secretary shall establish a
4 program of research, development, and demonstration to
5 enable components of commercial and residential buildings
6 to serve as dynamic energy loads on and resources for the
7 electric grid. The program shall focus on—

8 “(1) developing low-cost, low power, wireless
9 sensors to—

10 “(A) monitor building energy load;

11 “(B) forecast building energy need; and

12 “(C) enable building-level energy control;

13 “(2) developing data management capabilities
14 and standard communication protocols to further
15 interoperability at the building and grid-level;

16 “(3) developing advanced building-level energy
17 management of components through integration of
18 smart technologies, control systems, and data proc-
19 essing, to enable energy efficiency and savings;

20 “(4) optimizing energy consumption at the
21 building level to enable grid stability and resilience;

22 “(5) improving visualization of behind the
23 meter equipment and technologies to provide better
24 insight into the energy needs and energy forecasts of
25 individual buildings;

1 “(6) reducing the cost of key components to ac-
2 celerate the adoption of smart building technologies;

3 “(7) protecting against cybersecurity threats
4 and addressing security vulnerabilities of building
5 systems or equipment; and

6 “(8) other areas determined appropriate by the
7 Secretary.

8 “(b) CONSIDERATIONS.—In carrying out the pro-
9 gram under subsection (a), the Secretary shall—

10 “(1) work with utility partners, building own-
11 ers, technology vendors, and building developers to
12 test and validate technologies and encourage the
13 commercial application of these technologies by
14 building owners; and

15 “(2) consider the specific challenges of enabling
16 greater interaction between components of—

17 “(A) small- and medium-sized buildings
18 and the electric grid; and

19 “(B) residential and commercial buildings
20 and the electric grid.

21 “(c) BUILDINGS-TO-GRID INTEGRATION REPORT.—

22 Not later than one year after the enactment of the Grid
23 Modernization Research and Development Act of 2019,
24 the Secretary shall submit to the Committee on Science,
25 Space, and Technology of the House of Representatives

1 and the Committee on Energy and Natural Resources of
2 the Senate a report on the results of a study that examines
3 the research, development, and demonstration opportuni-
4 ties, challenges, and standards needed to enable compo-
5 nents of commercial and residential buildings to serve as
6 dynamic energy loads on and resources for the electric
7 grid.

8 “(1) REPORT REQUIREMENTS.—The report
9 shall include—

10 “(A) an assessment of the technologies
11 needed to enable building components as dy-
12 namic loads on and resources for the electric
13 grid, including how such technologies can be—

14 “(i) incorporated into new commercial
15 and residential buildings; and

16 “(ii) retrofitted in older buildings;

17 “(B) guidelines for the design of new
18 buildings and building components to enable
19 modern grid interactivity and improve energy
20 efficiency;

21 “(C) an assessment of barriers to the
22 adoption by building owners of advanced tech-
23 nologies enabling greater integration of building
24 components onto the electric grid; and

1 “(D) an assessment of the feasibility of
2 adopting technologies developed under the pro-
3 gram established under subsection (a) at De-
4 partment facilities.

5 “(2) RECOMMENDATIONS.—As part of the re-
6 port, the Secretary shall develop a 10-year roadmap
7 to guide the research, development, and demonstra-
8 tion program to enable components of commercial
9 and residential buildings to serve as dynamic energy
10 loads on and resources for the electric grid.

11 “(3) UPDATES.—The Secretary shall update
12 the report required under this section every 3 years
13 for the duration of the program under subsection (a)
14 and shall submit the updated report to the Com-
15 mittee on Science, Space, and Technology of the
16 House of Representatives and the Committee on En-
17 ergy and Natural Resources of the Senate.

18 “(d) PROGRAM IMPLEMENTATION.—In carrying out
19 this section, the Secretary shall—

20 “(1) implement the recommendations from the
21 report in subsection (c);

22 “(2) coordinate across all relevant program of-
23 fices at the Department to achieve the goals estab-
24 lished in this section, including the Office of Elec-
25 tricity; and

1 “(3) comply with section 8 of the Grid Mod-
2 ernization Research and Development Act of 2019.”.

3 **SEC. 7. INDUSTRY ALLIANCE.**

4 Title XIII of the Energy Independence and Security
5 Act of 2007 (42 U.S.C. 17381 et. seq.), as amended, is
6 amended by adding at the end the following:

7 **“SEC. 1312. INDUSTRY ALLIANCE.**

8 “(a) IN GENERAL.—Not later than 180 days after
9 the enactment of the Grid Modernization Research and
10 Development Act of 2019, the Secretary shall establish an
11 advisory committee (to be known as the ‘Industry Alli-
12 ance’) to advise the Secretary on the authorization of re-
13 search, development, and demonstration projects under
14 sections 1304 and 1304a.

15 “(b) MEMBERSHIP.—The Industry Alliance shall be
16 composed of members selected by the Secretary that, as
17 a group, are broadly representative of United States elec-
18 tric grid research, development, infrastructure, operations,
19 and manufacturing expertise.

20 “(c) RESPONSIBILITY.—The Secretary shall annually
21 solicit from the Industry Alliance—

22 “(1) comments to identify grid modernization
23 technology needs;

24 “(2) an assessment of the progress of the re-
25 search activities on grid modernization; and

1 “(3) assistance in annually updating grid mod-
2 ernization technology roadmaps.”.

3 **SEC. 8. COORDINATION OF EFFORTS.**

4 In carrying out the amendments made by this Act,
5 the Secretary shall coordinate with relevant entities to the
6 maximum extent practicable, including—

7 (1) electric utilities;

8 (2) private sector entities;

9 (3) representatives of all sectors of the electric
10 power industry;

11 (4) transmission organizations;

12 (5) transmission owners and operators;

13 (6) distribution organizations;

14 (7) distribution asset owners and operators;

15 (8) State and local governments and regulatory
16 authorities;

17 (9) academic institutions;

18 (10) the National Laboratories;

19 (11) other Federal agencies;

20 (12) nonprofit organizations;

21 (13) the Federal Energy Regulatory Commis-
22 sion;

23 (14) the North American Reliability Corpora-
24 tion;

25 (15) independent system operators; and

1 (16) programs and program offices at the De-
2 partment.

3 **SEC. 9. DEFINITIONS.**

4 Title XIII of the Energy Independence and Security
5 Act of 2007 (42 U.S.C. 17381 et. seq.), as amended, is
6 amended by adding at the end the following:

7 **“SEC. 1313. DEFINITIONS.**

8 “In this title, the following definitions apply:

9 “(1) **CRITICAL FACILITY.**—The term ‘critical
10 facility’ means a manmade structure that the Sec-
11 retary determines vital to socioeconomic activities
12 such that, if destroyed or damaged, such destruction
13 or damage could cause substantial disruption to
14 such socioeconomic activities.

15 “(2) **DISTRIBUTION AUTOMATION.**—The term
16 ‘distribution automation’ means systems and tech-
17 nologies that exert intelligent control over electrical
18 grid functions at the distribution level.

19 “(3) **RESILIENCE.**—The term ‘resilience’ means
20 the ability to withstand and reduce the magnitude or
21 duration of disruptive events, which includes the ca-
22 pability to anticipate, absorb, adapt to, or rapidly re-
23 cover from such an event, including from deliberate
24 attacks, accidents, and naturally occurring threats
25 or incidents.”.

1 **SEC. 10. TECHNICAL AMENDMENTS; AUTHORIZATION OF**
2 **APPROPRIATIONS.**

“Sec. 1304a. Smart grid modeling, visualization, architecture, and controls.”;
and

14 (D) by inserting the following after the
15 item related to section 1309:

“Sec. 1310. Grid resilience and emergency response.

“Sec. 1311. Hybrid energy systems.

“Sec. 1312. Industry Alliance.

“Sec. 1313. Definitions.”.

16 (2) ENERGY POLICY ACT OF 2005.—Section
17 1(b) of the Energy Policy Act of 2005 is amended
18 in the table of contents by inserting the following
19 after the item related to section 935:

“Sec. 936. Research and development into integrating renewable energy onto the electric grid.”.

1 (b) AUTHORIZATION OF APPROPRIATIONS.—There

8 (D) \$185,000,000 for fiscal year 2023;

9 and

10 (E) \$190,000,000 for fiscal year 2024;

11 (2) to carry out section 5 of this Act—

12 (A) \$20,000,000 for fiscal year 2020;

13 (B) \$21,000,000 for fiscal year 2021;

14 (C) \$22,050,000 for fiscal year 2022;

15 (D) \$23,153,000 for fiscal year 2023; and

16 (E) \$24,310,000 for fiscal year 2024; and

17 (3) to carry out section 6 of this Act—

18 (A) \$50,000,000 for fiscal year 2020;

19 (B) \$52,500,000 for fiscal year 2021;

20 (C) \$55,152,000 for fiscal year 2022;

21 (D) \$57,882,000 for fiscal year 2023; and

22 (E) \$60,775,000 for fiscal year 2024.
