Dear Administrator McCarthy:

This letter follows the Committee on Science, Space, and Technology's September 3, 2015, letter to the U.S. Environmental Protection Agency requesting documents and communications regarding EPA's action to limit the Pebble Mine in Bristol Bay, Alaska under section 404(c) of the Clean Water Act. EPA has taken numerous steps signaling its intention to carry out the 404(c) process on the Pebble Mine. On February 28, 2014, EPA Region 10 Administrator Dennis McLerran released a 15-day letter announcing the process to invoke the section 404(c) process with regard to the Pebble Mine. In July 2014, EPA Region 10 released its proposed determination to invoke a 404(c) action. These actions taken by the EPA have all preceded any formal permit applications submitted by Pebble Mine.

Since the Committee's September 3 letter, a report (Cohen report) was prepared by former Secretary of Defense William Cohen raising questions about the fairness of the process EPA undertook in its decision to invoke the section 404(c) process for the Pebble Mine.³ The Cohen report suggests that Administrator McLerran was presented with an options paper outlining various steps EPA should take to invoke the section 404(c) process to stop the Pebble

Mine – conclusions reached before any science based reports were produced.⁴ Most troubling, the Cohen report found that this document was inappropriately prepared by EPA staff with input from the counsel representing groups opposed to the Pebble Mine.⁵ The Cohen report suggests that Administrator McLerran was provided the options paper in advance of making a decision on whether to move forward with the 404(c) process.⁶

According to statements made to the *Wall Street Journal*, Administrator McLerran disputes that he reviewed the options paper and further states that it was not prepared by decision-makers at EPA. However, documents obtained by the Committee contravene Administrator McLerran's statements, instead suggesting that he was provided the options paper and was the chair of an options paper briefing on July 8, 2010. Administrator McLerran's recent statements raise many questions about the decisions that were made by EPA to pursue a section 404(c) action. In order for the Committee to better understand the process that EPA followed in invoking a 404(c) action; please make Region 10 Administrator Dennis McLerran available for a transcribed interview by Committee staff on November 2, 2015. Please confirm the date for Administrator McLerran's transcribed interview by October 27, 2015.

The Committee on Science, Space, and Technology has jurisdiction over environmental and scientific programs and "shall review and study on a continuing basis laws, programs, and Government activities" as set forth in House Rule X.
